Any modification to the scope of work, timeline, or price must be documented as a Change Order and approved in writing by both parties through the Jobbr platform before work on the changed scope begins. Verbal agreements are not binding under this Contract.

6. Warranties and Guarantees

The Contractor warrants all labour for a minimum of ____ **year(s)** from the completion date. Material warranties are passed through to the Homeowner per manufacturer terms. Any defects arising within the warranty period will be corrected by the Contractor at no additional cost.

7. Dispute Resolution

In the event of a dispute, the following process applies:

1. Either party contacts Jobbr at hello@jobbr.ca or through the platform dispute button.
2. Jobbr reviews the job timeline, progress photos, messages, and contract within 5 business days.
3. Jobbr proposes a resolution. Both parties have 48 hours to accept or counter-propose.
4. If unresolved, both parties agree to binding mediation under the laws of the Province of Quebec.
5. Escrowed funds remain frozen until the dispute is resolved — protecting both parties.

If the Contractor abandons the project, Jobbr will release unreleased milestone funds to the Homeowner after a 10-business-day notice period and review of work completed to date.

8. General Terms

- This Contract is governed by the laws of the Province of Quebec and the federal laws of Canada applicable therein.
- The Contractor holds valid liability insurance (minimum \$1M) and is responsible for CNESST compliance for all workers on site.
- The Homeowner grants the Contractor reasonable access to the property during agreed working hours.
- Daily progress photos must be uploaded to the Jobbr platform by the Contractor at the end of each working day.
- Neither party may assign this Contract without written consent of the other party.
- This document, together with any approved Change Orders, constitutes the entire agreement between the parties.
